## Master Addendum to Software Terms of Use/Service Waukegan Community Unit School District #60 ("the district") & BrainPOP LLC ("the vendor")

Effective November 1, 2021, the vendor's Terms of Service/Use are modified as set forth herein, relative to all prospective purchases of vendor's Physical Products, Digital Products, Connected Products, Services and Pilots when such purchases, although paid for by the district, are not to be used by a the district, but rather are to be used by a third party who operates a private school. In such instances, relative to the vendor's Terms of Use/Service:

- 1. **Authorized User.** "Authorized User," "You or Your," "User," and any similar term means the entity that owns the private school in question, and does not include the district. The district shall have no obligations or duties under the vendor's Terms of Use/Service, and the district shall in no way be responsible for ensuring compliance with the vendor's Terms of Use/Service on the part of the private school in question.
- 2. **Indemnity**. Without limiting the general application of Section 1, the district shall not be liable for indemnifying the vendor in any way relative to claims, losses, damages, etc. arising out of or relating to the private school's use of the vendor's products, services, and pilots.
- 3. **Governing Law and Jurisdiction.** The agreement relative to each purchase shall be governed by the laws of the state of Illinois; and any action at law or in equity arising out of or relating therefrom shall be subject to the exclusive jurisdiction of the state courts of Lake County, Illinois, and the vendor irrevocably consents and submits to the personal jurisdiction of such courts.
